This regulation will be implemented soon to the following conditions: Halal Correct Certificate will be provided with Logo (Saudi SHC-SFDA), at your request Halal Correct will upgrade your product- batch-certificate with the logo. From 01-10-2024, each shipment will be provided with a product-batch-halal certificate, at your request Halal Correct will draw up a product-batch-certificate and send it to you digitally.

Saudi Halal Authorities SFDA implement a fix price per Halal Shipment Certificates of 1000 (SAR) (approximately 239 EUR) The fee is for each shipment up to 27.000 KG weight.

HS code must we selected for type of product, if you can't link/select, please contact us for support.

In short, all types of foods and beverages are now required to be Halal certified and receive a Halal Facility Certificate. Failure to do so may result in export stoppage by border control starting 1 October 2024

Arabic and English is the language must be used for product certificate including the annex. For any support regarding the Arabic please contact us by e-mail.
